Members of the CSDWID Board:

Please see summary report of work performed in April - May by MWM in the CS System

- 0 leaks repaired or reported since last board report
- Water loss continued to decline this month to 21% from a high of 30% in April
 - We continue to work through leak detection of entire system to try and reduce water loss
- Bacteria samples were taken and found absent of any contaminants.
- I stated this on my last board report but need guidance on how to proceed to be able to have reimbursement from FD before the June 30th end of fiscal year:
 - The Pinedale Clay Springs Fire Department has committed to purchasing two fire hydrants with no additional parts to install for Clay Springs DWID. The total cost is just shy of \$6,000. The fire chief has requested that Clay Springs DWID make the purchase and submit an invoice to the Fire District for reimbursement. The funds are only available for this fiscal year so we would need to make the purchase sooner rather than later. Please advise on how the board would like to move forward. The installation doesn't have to be performed in this fiscal year by the district so a further discussion about installation and parts costs can be had at a later date.
- I sent the board an update around the first but wanted to include the WIFA Projects Forgivable Principal Recommendations in my report (please note that these are recommendations and not guaranteed until final approval by WIFA Board):
 - **For the Small Main Line Replacement project (3500' of mainline replaced)**
Total cost applied for: \$250,000
Recommended forgivable principal: 100% or \$250,000
Additional Funding: \$50,000 Design and Engineering & \$25,000 Davis Bacon Act Assistance
 - **Service Line Replacement project (90 service lines replaced)**
Total cost applied for: \$375,000
Recommended forgivable principal: 90% or \$337,500
Additional Funding: \$50,000 Design and Engineering Grant & \$25,000 Davis Bacon Act Assistance
